# Report of 36th Annual Conference of ASU

The Association of Southern Urologists (ASU) proudly conducted its 36th Annual Conference – SZ-USICON 2025 at CK Conventions, Vijayawada, Andhra Pradesh, from 11th to 13th July 2025. The conference was hosted by the Vijayawada Association of Genito-Urinary Surgeons and led with distinction by Organising Chairman Dr. C.V. Sathish Kumar and Organising Secretary Dr. Dheeraj Kasaraneni, who made impeccable arrangements and ensured excellent hospitality for the delegates.

The scientific program, conceptualised and executed under the guidance of the ASU Council led by President Dr. G. Chengalvarayan and Honorary Secretary Dr. Chandra Mohan Vaddi, was intellectually enriching and spanned three full days of diverse academic activities. Highlights included eight focused masterclasses covering subspecialties, unique sessions such as Reclaim Urology, Youth Urology, Expert Talks, and the USI-ISU Joint Academic Session, as well as the much-appreciated BPH 360 Live Workshop organised by VAGUS. # **Minutes of Annual General Body Meeting**

Minutes of the Annual General Body Meeting [GBM] 2025  
held on 12th July 2025 at 5 PM, CK Conventions, Vijayawada,  
Andhra Pradesh

## **1. Call to Order**

The meeting was called to order by President Dr. G. Chengalvarayan.

Presentation and Approval of Agenda: The agenda for the meeting was presented by President Dr. G. Chengalvarayan. It was approved by Dr. R Keshavamurthy and seconded by Dr. M Ganesh Kamath.

## **2. Obituary**

## **3. President's Opening Remarks**

### 1. TAPASUCON 2024

TAPASUCON 2024 was conducted from 20th to 22nd September 2024 in Chennai with a total of 365 delegates in attendance. The event was organised at CURI Hospital (live surgeries) and ITC Grand Chola (academic sessions). The theme of the conference was "Robotic Surgery and Innovations in Urology". Organising Chairman: Dr. P.B. Sivaraman, Organising Secretary: Dr. Ananthakrishnan Sivaraman. ASU President and Secretary participated in the inaugural ceremony. The event featured robotic prostatectomies, partial nephrectomy, and hands-on sessions.

### 2. UAKON 2024

UAKON 2024 was held on 19th and 20th October 2024 at Hotel Leela Ashtamudi, Kollam, with 175 delegates. Organising Chairman: Dr. Bipin Das, Organising Secretary: Dr. Agish M. It was the 38th Annual Conference of the Urological Association of Kerala. The highlight was the Prof. Roy Chally Oration delivered by Dr. Madhusudan Agrawal. Core academic themes included BOO, urolithiasis, and reconstructive urology.

### 3. KUACON 2024

It was the 29th Annual Conference of the Karnataka Urological Association. Notable lectures included the PVG Oration by Dr. R.B. Sabnis and the Dr. M.P. Raju Endowment Lecture by Dr. P.S. Indu.

### 4. SOGUS AP & TS 2024

SOGUS AP & TS 2024 was organised on 9th and 10th November 2024 at Sri Krishna Hotel, Nizamabad, with participation from over 300 delegates. Organising President: Dr. K. Dayakar, Organising Secretaries: Dr. A. Raghavender and Dr. M. Anand Kumar. The 36th Annual Conference of SOGUS featured 26 academic sessions, semi-live surgeries, and named orations—Dr. Ranganadha Rao Oration by Dr. Sudhir Rawal and Revathi Ramachandran Oration by Dr. Anita Patel.



## **2. ASU Prof. H.S. Bhat Midterm Workshop – 2024**

Held on 17th November at IISC, Bengaluru with NU Hospitals. Dr Venkatesh Krishnamoorthy is the organising Chairman. The theme of the session is on Second Thought. Focused on clinical decision-making in urology through case-based sessions.

The Journal of the Association of Southern Urologists (JASU) continues to maintain high academic standards and visibility under the editorial leadership with two issues.

## 6. Treasurer's Report – Presented by Dr. Nischith Dsouza:

Dr. Nischith Dsouza, Treasurer, presented the complete financial report for the year 2024–2025. The audited accounts till 31st March 2025 had already been circulated to all members, placed before the General Body Meeting (GBM), and all financial details were presented in full during the session.

As on 9th July 2025, the balance available in the Savings Bank Account stood at ₹42,83,988. The Association also holds Fixed Deposits with SBI amounting to ₹2,29,51,130 which includes funds in Named Corpus accounts totalling ₹1,07,01,130, reflecting a strong and stable financial position.

## 7. Approval of Auditor Report:

The Auditor's Report, covered all financial transactions and statements up to 31st March 2025, The Auditor's report showed Income & Expenditure for the year ending 31.03.2025, Liabilities & Assets sheet as on 31.03.2025 & Details for Funds Held in Trust for Specific Purposes as on 31.03.2025 was discussed and formally approved by the General Body.

The report confirmed that the accounts were properly maintained in accordance with established financial standards, with no material discrepancies.



The Council appreciated the Treasurer's comprehensive and transparent presentation.

Dr R Keshava Murthy suggested to show the Membership Corpus separately in the Auditor report, it has shown all together including other corpus. Dr M Shivalingaiah suggested to keep the FD's in the Flexi FD Account, the rate of interest is more.

Talk with bank people. Treasurer Report & Auditor Report were passed by Dr Keshavamurthy and seconded by Dr Shivalingaiah.

## **8. Budget for the Forthcoming Year (2025-2026)**

The budgeted expenditure for the upcoming financial year was presented.

The expected income includes Membership Fees, Interest from Corpus and Savings Accounts, Sponsorships, and the surplus amount to be transferred from SZUSICON 2024. The Treasurer confirmed that all planned activities can be supported within the available and projected resources.

Dr. Vinod KV suggested that council members should also organize programs on social awareness activities and research updates, in addition to regular scientific programs, as part of their council member activities.

Dr CS Ratkal Suggested to conduct the Health Camps

Dr G.Chengalvarayan suggested spending Rs.50, 000 from the miscellaneous expenses for Health Camps or social awareness. It meant charity work. It can be done by council members.

Dr. Krishnasamy Kannan & Dr. CS Ratkal sir said council Member activity was primarily bought in to empower the council members hence any kind of activity done by them for ASU will hold good. After much discussions the GBM agreed that from next year onwards the council member activities will not be in the form of meeting as before. The general body suggested that the council can discuss this in detail, take suggestions from members and come up with new activities.

The President told that the council was required by the last GBM to consider whether the Travelling Fellowship amount given to Postgraduates needs to be increased and it was considered by the council and increased from Rs.5000 to Rs.10000 per fellowship GB Agreed. Budget for the forthcoming year is passed by Dr N Mallikarjuna Reddy and Seconded by the Dr Vinod KV and approved by the GB.

## **19. Finalisation of the accounts of SZUSICON 2024**

### ***SZUSICON 2024 – Financial Report***

Dr. D. Paul Vincent, Organising Secretary of SZUSICON 2024, presented the final audited financial statement. Total income: ₹5, 32, 79,197, Total expenditure: ₹4, 56, 56,172. Excess of income over expenditure: ₹76, 23,025

Distribution of surplus: ASU (40%) – ₹30, 49,210, TAPASU STATE Association (30%) – ₹22, 86,907, MANUS Trust (30%) – ₹22, 86,907. The GB commended Dr. Paul Vincent and team for excellent organization and financial transparency. It was proudly recorded that SZUSICON 2024 contributed the highest-ever donation to ASU, amounting to ₹30, 49,210. For the same GB congratulated the Madurai Team. Dr Paul Vincent assured that this donation amount will be transferred to the corpus of ASU. Both the auditors of SZUSICON 2024 and ASU Auditor discussed and confirmed that the donation will be transferred to ASU Corpus.

Dr Gnanasekaran, Dr Paul Vincent, Dr Rajeevan handed over the cheque of Rs.30, 49,210/- to President and same given to Treasurer.

## **20. SZUSICON 2026**

Dr. Zeeshan Hameed representing Organising Committee, On behalf of Karnataka urology Association and Mangalore Urology Forum they are conducting the SZUSICON 2026 Annual conference at Mangaluru from 7th to 9th August 2026. He presented the venue details, proposed tariff plan, and played a venue promotional video. GBM approved the SZUSICON 2026 tariff, Venue and confirmed the Dates. They also mentioned that they are giving last year tariff for Super Early bird for one week from the completion of SZUSICON 2025.





## **21. Venue SZUSICON 2027**

Dr. Joju Varghese presented the venue proposal for SZUSICON 2027, to be hosted by the Urology Club of Thrissur with tentative dates of 6th–8th August or second week of August 2027; the Organising Committee includes Dr. Darwin D Therattil (Chairman), Dr. Joju Varghese Akkara (Organising Secretary), and Dr. Midhun Gopalakrishnan (Treasurer), and three preferred venues—Apollo Adlux Convention Centre, Lulu Convention Centre (Hyatt Regency), and Telcon Convention Centre—were suggested, pending finalisation after ASU inspection; proposed tariff rates were accepted by the General Body, and a promotional video was presented.

The venue for USICON 2029 was discussed, and Dr. Sachin Dharwadkar, Secretary of KUA, informed that the Bangalore Urology Society is willing to host the conference; the ASU Council requested details of the organising committee, which will be communicated after the KUA Annual Conference General Body Meeting scheduled for October 2025 Ending.

## **23. JASU**

Dr. Mallikarjuna Reddy informed the ASU of his decision to step down as Editor-in-Chief of JASU, which was accepted by the Council following his email. Applications were invited, and Dr. Arun Ramdas Menon from Amrita Institute of Medical Sciences Kochi, previously the Associate Editor, applied for the post. His candidature was presented in the General Body Meeting and was approved by the GBM as the new Editor-in-Chief.

The Associate Editor post, vacated by Dr. Arun Ramdas Menon, could be filled by Dr. Maneesh Sinha from NU Trust Hospital, Bengaluru who had applied for this post and his appointment was also approved by the GBM. The GBM also discussed and approved that the tenure of the Editor-in-Chief & Associate Editor posts will be two years. Dr. Mallikarjuna Reddy expressed his gratitude to the ASU Council for the opportunity to serve as Chief Editor for the past two years.

## **24. Legal Cell for ASU**

The President proposed the formation of a Legal Cell for ASU to address legal and organisational matters. The Council approved the formation, comprising the President, Secretary, and members Dr. Ganesh Gopalakrishnan, Dr. K.S.N. Chary, Dr. Krishnasamy Kannan, Dr. R. Keshava Murthy, and Dr. P. Ginil Kumar. The GBM approved the proposal. It was agreed to include the Treasurer in the Legal Cell following member suggestions.



Two approved lawyers were proposed: Mr. Venkat Ramani, senior lawyer from Tamil Nadu with over 40 years of experience, former AAG and Supreme Court representative, and his assistant Mr. Mohammed Ismail. Their tenure will be for one year, with provision for change or continuance as deemed necessary by the Committee.

Dr. Arun Kumar Paranjothi and Dr. D. Ramesh suggested that a framework with rules, regulations, and proper documentation be established.

The Legal Cell formation was officially approved by the GBM, proposed by Dr. Girish Nelvegi and seconded by Dr. Rajeev Ayyappan.

The revised guidelines were circulated to all members in the month of May 2025, inviting feedback or queries via email. As there were no unanswered queries or objections from the members, the same set of guidelines was presented during the General Body Meeting (GBM) and unanimously approved

## **29. Letters from Members:**

A letter was received from Dr. N Mallikarjuna Reddy, addressing a complaint forwarded by the Telangana Medical Council (TMC). The complaint originated from the Interventional Radiology Society, concerning a scientific program titled "Vascular Interventions in Urology for Urologists" scheduled on 12th October 2025. The Interventional Radiology Society alleged that the event was unethical and amounted to a promotional activity.

Dr. Mallikarjuna Reddy has submitted an explanation letter to the Telangana Medical Council, which was jointly endorsed by the State Urology Association.

The General Body Meeting (GBM) discussed the matter and felt that Dr. N Mallikarjuna Reddy seems to have adequate capability to do the said intervention and his intention on teaching does not seem to be unethical and recommended that it be referred to the ASU Legal Cell for review and ASU council to give an appropriate response.

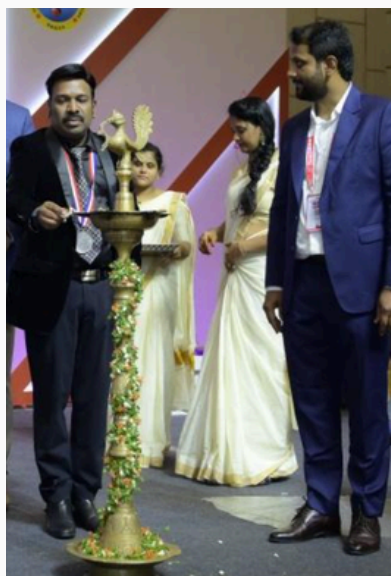

## Obituary



### **Dr. G. Venugopal**

Dr. G. Venugopal, retired Professor and HOD Urology was among the stalwarts of Urology from Thiruvananthapuram known for his work in Laparoscopy, Retroperitoneoscopy and Kidney transplantation and was one of the key figures who put Thiruvananthapuram on the national map.

- He did MBBS from Medical College Kottayam during the period 1975-1981 and joined as Lecturer in Forensic Medicine at Kottayam.
- In 1985 he was appointed as Lecturer in Urology through PSC.
- He passed MS general surgery in 1989 and MCh Urology in 1991 from Thiruvananthapuram.
- He created the third Urology unit in Urology in Thiruvananthapuram Medical College in 1998 while he was an assistant Professor.
- In 2001 he became Associate Professor and Professor in 2008.
- He was elected as the UAK Secretary in 2011
- He became the HOD the post which he held till his superannuation in 2020
- The workshop he held on retroperitoneoscopy at Kovalam in 2018 was well appreciated.
